

We Energies supplier (Taulia)

As previously communicated, WEC Energy Group is converting to a new Enterprise Resource Planning (ERP) system on Jan. 1, 2018, to allow standardized systems and processes across entities. Your support as a valued business partner is appreciated throughout this transition.

All suppliers are asked to submit invoices by Dec. 20, or to hold until after Jan. 1, 2018. Invoices received after Dec. 20 may result in delayed payments. The We Energies supplier portal will be unavailable beginning the evening of Dec. 26. Check the portal message board for portal availability.

New supplier portal

With the transition to a new ERP system, the new supplier platform will continue to provide free, 24/7 access to invoice and payment status, electronic invoicing capabilities, and comprehensive supplier self-services and early payment options. The portal facilitates early payment offers in exchange for invoice discounts. As a current WEC Energy Group supplier using the Taulia platform, we expect you will experience very few changes.

What does this mean for me?

In January 2018, WEC Energy Group will launch the new supplier portal for all suppliers of WEC Energy Group and its subsidiaries. All business transactions, including electronic invoicing, will use the new portal. We are committed to a seamless transition and have worked with Taulia, the portal supplier, so that you will experience limited interruption in your business operations throughout this process.

Since you are currently a supplier in the Taulia system, no actions are required of you. You will continue to have access to historical data in your current We Energies supplier portal, but transactions after Jan. 1 will take place in the WEC Energy Group's supplier portal. Open purchase orders will be available in the WEC Energy Group supplier portal.

Your new WEC Energy Group vendor ID and your email will be merged to provide a single sign-on, meaning you will be able to toggle between We Energies' supplier portal and WEC Energy Group's supplier portal. You will receive a confirmation email from portal@taulia.com indicating that your account is updated to do business with WEC Energy Group.

Change in payment terms

Existing payment terms are being transferred to similar payment terms in the new system. All open purchase orders and invoices have been converted to related payment terms. For example, a current payment term of net 42 has been converted to net 40 in the new system. Any new POs or invoices after Jan. 1, 2018, will use new payment terms.
